- 1 All pages are Bookmarked. To navigate quickly through the CD-ROM, simply click the bookmark tab found to the left of your screen. The content headings are found under the Index of Speakers. Click on each heading to jump to the relevant paper.
- 2 Use the arrow → located in the middle of your toolbar to take you back to your previous view.
